Flag 1: In March 2013, representatives of the Third Party appeared before a commission of the Australian federal parliament along with those of Apple and Microsoft due to evidence found that large IT companies and copyright holders charge Australians on average 50% increased prices. The three companies had initially refused to appear before



the commission but were warned that if they did not appear they would be held in contempt of parliament and liable to fines and even prison sentences.⁶

Flag 2: In December 2023, the Portony Law Firm filed a class action lawsuit against the Third Party on behalf of the Third Party's investors. The lawsuit alleges false or misleading statements and failure to disclose key information during the Class Period from July 2021 to September 2022. The case focuses on the Third Party's competition with Figma, a company gaining market share in user experience design. The complaint asserts that Figma were outpacing the Third Party in this domain, and the Third Party's attempts, including their product "Express," were ineffective in countering Figma's growth. The lawsuit contends that the Third Party were losing market share to Figma, leading to a nearly 17% drop in the Third Party's stock price after the announcement of their intention to acquire Figma for USD 20 billion in cash and stock in September 2022. There is no publicly available source confirming the outcome of this lawsuit.

Flag 3: The Third Party are accused of supporting and sponsoring Russian Terrorists. There are two articles claiming that the Third Party are involved in selling faulty software, including Magento 2 and PWA. They permit the use of their technology for propaganda and funding terrorist activities. The articles also indicate that the Third Party are actively engaged in business dealing with Russia, approving license renewals for their products with Russian corporate clients.⁸ The allegations also mention that the Third Party are selling pro-Russian images on Adobe Stock,⁹ such as maps of Ukraine without Crimea, Donetsk, and Luhansk, as well as flags representing territories annexed by Russia.¹⁰

Flag 4: The Third Party were accused of tax avoidance practices by retaining over USD 3 billion of their profits overseas, classifying them as "permanently reinvested" foreign earnings in 2015. The Third Party have paid minimal taxes on these profits to any

Additionally, the report indicates that repatriating the Third Party's foreign cash could result in a USD 900 million tax obligation, suggesting that the offshore funds are predominantly situated in a tax haven country with a single-digit tax rate.¹²
